## STUDENT HOUSING GENERAL GUIDELINES

- Before you fill out this application form, please read the following information on some basic rules and regulations affecting students who choose to access housing services. It is important to consider possible lifestyle changes while you are living as a student in a college housing environment. These basic housing rules are enforced on a strict basis. Your signature on this form indicates that you understand your responsibilities as a patron of Portage College Student Housing Services.
  - Alcohol is not permitted on the premises.
  - Firearms are not permitted on the premises.
  - Pets are not allowed.
  - Rates include furniture, appliances, all utilities and parking. *Cable and telephone hook-ups/long distance charges are your responsibility.*
  - A cancellation fee will be deducted from your security deposit, if you fail to provide Student Housing with at least two weeks' notice that you will not be moving into Student Housing.
- You will be required to sign an Occupancy Contract, which outlines your responsibilities and provides you with detailed housing rules and regulations.
- On-campus family housing is available for students who have lived 75 kms from the town of Lac La Biche for more than three years. There is no kilometer restriction for single students.
- All family applicants should include a landlord reference with their application. If you have no previous rental history, you will be required to provide a personal character reference. Failure to supply this information may delay the processing of your application.
- Previous history in student housing will also be considered.
